



Fiscal Year 2015

\$141 Million in Total Awards With 79% in Top Seven NAICS




Fiscal Year 2014



The OCC charters, regulates, and supervises national banks and federal savings associations and supervises the federal branches and agencies of foreign banks. The OCC's mission is to ensure that national banks and federal savings associations operate in a safe and sound manner, provide fair access to financial services, treat customers fairly, and comply with applicable laws and regulations.

The agency was established in 1863 as an independent bureau of the U.S. Department of the Treasury. Headquartered in Washington, D.C., and with offices throughout the country, the OCC employs approximately 4,000 full-time staff members.

The OCC established the Office of Minority and Women Inclusion (OMWI) in January 2011 to meet the requirements of the Dodd-Frank Wall Street Reform and Consumer Protection Act. The OMWI Executive Director and the Diversity and Inclusion Team develop standards for

- increasing the participation of minority- and women-owned businesses in the OCC's programs and contracts.
- coordinating technical assistance to minority- and women-owned businesses.
- promoting equal employment opportunity and the racial, ethnic, and gender diversity of the OCC's workforce and senior management.
- assessing the diversity policies and practices of entities the OCC regulates.

Supplier Diversity at the OCC

The OCC's annual procurement expenditures are approximately \$150 million, representing about 1,500 contracts. The OCC uses U.S. General Services Administration (GSA) multiple award schedule (MAS) contracts, government-wide acquisition contracts (GWAC), and multi-agency contracts (MAC) for much of its contracting needs. For items not available through multiple award contracts, the OCC posts requests for proposals on the Federal Business Opportunities website, www.fbo.gov.

The OCC is committed to supplier diversity and awarding contracts to small businesses, small disadvantaged businesses, women-owned small businesses, service-disabled-veteran-owned small businesses, and HUBZone small businesses, and proudly achieves its annual U.S. Small Business Administration (SBA) small business goals.

Moreover, the OMWI Business Activities Program is committed to increasing opportunities for all minority- and women-owned businesses, as well as providing technical assistance to these businesses. For the last five years, over 35 percent of the OCC's annual contracting payments were made to minority- and women-owned businesses.
